After discussion of the subject of some blocks and streets in Mingo, described as Block 1, Lots 1 through 20 and alley; Block 8, Lots 1 through 20, and alley; Block 9, Lots 1 through 20, and alley. AND the East Side of Benson street. ~~AND the North Half of Misner Avenue~~ All of Byars Avenue, Belle Avenue, Davis Street, lying East of Jensen Street in the Village of Mingo, Kansas, the adoption of the following Resolution was moved by Ron Evans, Glen H. Kersenbrock seconded, motion was unanimous.

WHEREAS, the Board of County Commissioners were presented a petition by Leslie J. and Benjamin L. Keller resident of said real estate of the platted Townsite of Mingo, Kansas, requesting said blocks and streets be vacated pursuant to law.

WHEREAS, the board determined that no private rights will be injured or endangered by such vacation and that the public will suffer no loss or inconvenience thereby, and that justice to the Petitioner, the prayer to the Petitioner be granted and an order that such vacation be granted.

WHEREAS, BE IT RESOLVED BY THE THOMAS COUNTY BOARD OF COUNTY COMMISSIONERS, that the streets and alleys mentioned above be closed. Approved this 13<sup>th</sup> day of November, 2001.

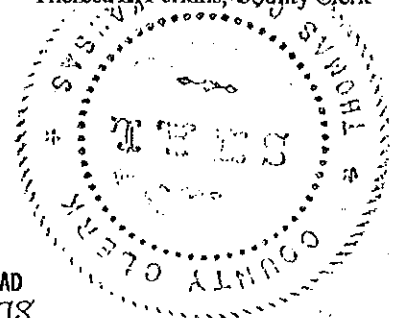
