

**R&S CONTRACT FOR SERVICES**  
**For**  
**Ortho-Editing**

THIS AGREEMENT made and entered into this 7<sup>th</sup> day of November, 2011, by and between the Thomas County, Kansas, hereinafter referred to as "the County", and R&S Digital Services, Inc., hereinafter referred to as "R&S".

WHEREAS, the County desires to secure the services of R&S to provide Ortho Editing Services, and R&S agrees to perform said services which shall include the following:

**Ortho-Imagery Editing** – R&S will provide editing services for the delivery of your Orthos from Sanborn. A detailed review of all ortho tiles will be performed and any tiles found to be deficient will be referred back to Sanborn for resolution. Additional edits will be performed to check the alignment of 911 Map features to the new ortho-base. A report will be generated and provided to the County detailing the areas and status of any misalignments that do not fall within an acceptable accuracy tolerance. Also, provided in the report will be recommendations on how to resolve any inaccuracies that might be identified. Specifically, the following tasks will be performed:

Review each ortho for the following:

- Image Clarity
- Spatial referencing
- Alignment with existing features from County/911 GIS
- Detail any problems found with Delivery
- Forward any reworks to Sanborn for resolution

WHEREAS, the County and R&S agree that the geographic areas subject to this agreement shall be within the County Boundary of Thomas County KS.

WHEREAS, the County agrees to provide R&S with copies of its Digital Orthos

WHEREAS, the parties agree that time is of the essence. In the course of fulfilling its commitment, R&S will depend upon the County to provide various items of information and data. In order to meet its delivery schedule, R&S will depend upon the County to provide any and all necessary information and data in a timely manner.

WHEREAS, the County agrees to pay and R&S agrees to accept as consideration for the above services, the amount of \$3,000. Said consideration will be earned and payable upon completion and delivery of the above-described services to the County.

WHEREAS, R&S agrees to complete and deliver all the above-described services within 45 calendar days of Data sources being submitted to R&S and notice to proceed being given by the County to R&S.

FURTHERMORE, it is agreed by both parties that this Contract for Services may be extended to include additional services as determined by the Parties.

THIS AGREEMENT shall be binding upon the parties hereto, their heirs, devisees, legatees, personal representatives, successors, and assigns.

IN WITNESS WHEREFORE the parties have hereunto set their hands the day and year first above written.




