

ADDENDUM

This Addendum to the Agreement dated June 12, 2012, by and between the Sherman County Rural Fire District of Sherman County, Kansas, a municipality, hereinafter referred to as Party of the First Part, and Fire District #5, County of Thomas, State of Kansas by and through the Board of County Commissioners of Thomas County, Kansas, hereinafter referred to as Party of the Second Part, is entered into on this the 9th day of July, 2012, by the Party of the First Part, Party of the Second Part and City of Brewster, Kansas.

WHEREAS, the parties entered into an Agreement dated June 12, 2012, regarding the Party of the First Part providing fire protection services for the Party of the Second Part.

WHEREAS, the parties agree that certain items need clarification under the Agreement.

WHEREAS, the parties agree that this Addendum shall modify certain paragraphs to clarify the parties' intention under the Agreement.

WHEREAS, it is necessary to add an additional party to the Agreement, namely, the City of Brewster, Kansas.

NOW, THEREFORE, IT IS UNDERSTOOD AND AGREED that

The City of Brewster, Kansas should be added as a party to the Agreement effective the date of the Original Agreement. The first paragraph of the Agreement shall be amended to read as follows:

"THIS AGREEMENT, is made and entered into this 12th day of June, 2012, by and between the Sherman County Rural Fire District of Sherman County, Kansas, a municipality, hereinafter referred to as Party of the First Part, and Fire District #5, County of Thomas, State of Kansas by and through the Board of County Commissioners of Thomas County, Kansas, hereinafter referred to as Party of the Second Part and the City of Brewster, Kansas hereinafter referred to as City of Brewster."

The last WHEREAS statement should be amended to read as follows:

"WHEREAS, the parties agree that they would be mutually benefitted under an agreement whereby Party of the First Part would provide certain fire protection services for Party of the Second Part and the City of Brewster."

The last sentence of the first full paragraph on page 2 of the Agreement, is amended read as follows:

"The Party of the First Part and the Party of the Second Part will share equally any costs above \$5,000, with respect to any unanticipated repairs and expensive major breakdown repairs to the equipment provided by Party of the First Part."

A signature page should be added to the Agreement for the City of Brewster.
