CALL TO ORDER

Chairman Mike Baughn called the Commissioners Meeting to order at 3:00 p.m. in the Commissioners room of the Thomas County Courthouse on Saturday, October 3, 2020 with Commissioners Brad Flipse (via GoTo) and Francis Britton, County Clerk Shelly Harms (via GoTo), County Health Administrator Emily Strange (via GoTo), Emergency Management Director David Becker (via GoTo), and others (via GoTo).

AGENDA: Commissioner Francis Britton moved to approve the Saturday, October 3, 2020 agenda to convene as the Thomas County Board of Health as prepared by County Clerk Shelly Harms; the motion was seconded by Commissioner Brad Flipse; with no further discussion the motion carried unanimously.

CONVENE AS THOMAS COUNTY BOARD OF HEALTH: Commissioner Brad Flipse moved to convene as the Thomas County Board of Health; the motion was seconded by Commissioner Francis Britton; with no further discussion the motion carried unanimously.

ISOLATION ORDERS: Health Administrator recommended that Patients A – I be isolated by the Thomas County Board of Health with isolation dates ranging from September 20, 2020 to October 11, 2020. Board of Health Officers agree to the recommendation and Chairman Baughn so ordered.

QUARANTINE ORDERS: Health Administrator recommended that Patients A – C be quarantined by the Thomas County Board of Health with quarantine dates ranging from September 27, 2020 to October 21, 2020. Board of Health Officers agree to the recommendation and Chairman Baughn so ordered.

HEALTH OFFICER: Health Administrator Emily Strange has asked KDHE to help with investigations as the local County Health is very busy, other cases have been sent to KDHE and Ms. Strange is waiting on their recommendations.

ADJOURN AS BOARD OF HEALTH AND RECONVENE AS BOARD OF COUNTY COMMISSIONERS: With no further business as the County Board of Health Commissioner Francis Britton moved to adjourn and to reconvene as the Thomas County Board of Commissioners.; the motion was seconded by Commissioner Brad Flipse; with no further discussion the motion carried unanimously.

APPROVE ISOLATION AND QUARANTINE ORDERS: Commissioner Francis Britton moved to approve the nine (9) isolation patient orders and the three (3) quarantine orders as recommended by Health Administrator Emily Strange and the Thomas County Board of Health; the motion was seconded by Commissioner Brad Flipse; with no further discussion the motion carried unanimously.

ADJOURN: With no further business Commissioner Francis Britton moved to adjourn at 3:08 p.m.; the motion was seconded by Commissioner Brad Flipse; with no further discussion the motion carried unanimously.
