

Thomas County Commission – REGULAR and BOARD OF HEALTH

October 4, 2020

CALL TO ORDER

Chairman Mike Baughn called the Commissioners Meeting to order at 3:00 p.m. in the Commissioners room of the Thomas County Courthouse on Sunday, October 4, 2020 with Commissioners Francis Britton and County Clerk Shelly Harms, joining via GoTo were Commissioner Brad Flipse and Health Administrator Emily Strange.

AGENDA: *Commissioner Francis Britton moved to approve the Sunday, October 4, 2020 agenda to convene as the Thomas County Board of Health as prepared by County Clerk Shelly Harms; the motion was seconded by Commissioner Brad Flipse; with no further discussion the motion carried unanimously.*

QUARANTINE ORDERS: Health Administrator Emily Strange has no patients as KDHE is conducting the interviews and has not reported by to Ms. Strange.

HEALTH OFFICER: Health Administrator Emily Strange has forwarded the Sherman County Health Officers offer to step up as the Thomas County Health Officer to CMCI Scott Focke, Greg Unruh, and Dan Kuhlman but has not heard anything yet.

APPROVE ISOLATION AND QUARANTINE ORDERS: *Commissioner Francis Britton moved to approve the three (3) Isolation patient orders as recommended by Health Administrator Emily Strange and the Thomas County Board of Health; the motion was seconded by Commissioner Brad Flipse; with no further discussion the motion carried unanimously.*
